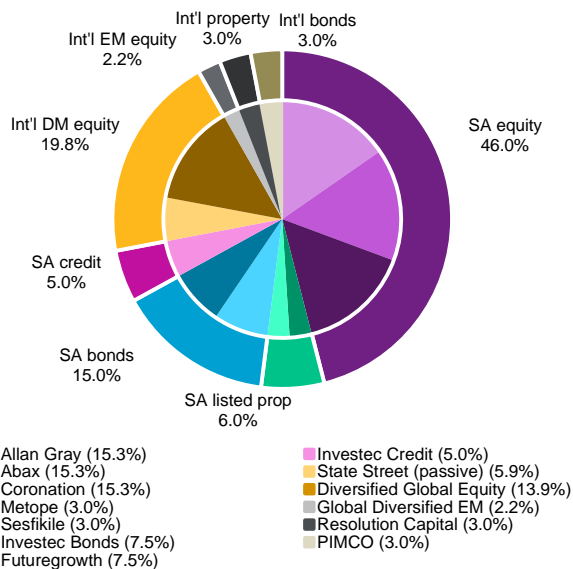

RISK: The portfolio is intended for members with a long investment horizon. Volatility should be expected over the short term and negative returns may be experienced over a one year period.

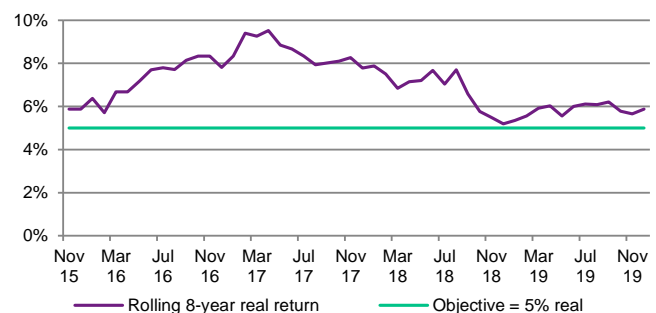
