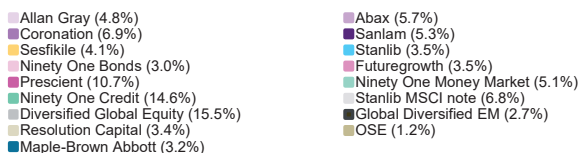
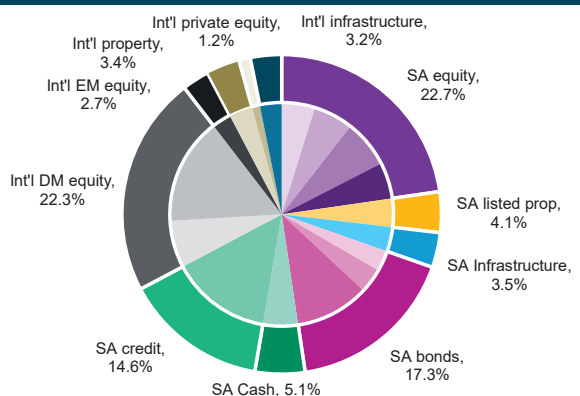

PORTFOLIO DESCRIPTION: A blend consisting of 40% of the Long Term Portfolio and 60% of the Conservative Portfolio provides a market related investment that follows a specialist investment approach, diversifying across asset classes and asset managers.

PORTFOLIO OBJECTIVE: The blend of these two portfolios aims to provide a return that exceeds inflation by 3.8% p.a. net of fees and other costs over measurement periods of 5 years.

RISK: The portfolio is intended for members with a medium term investment horizon. Volatility should be expected over the short term and negative returns may be experienced over a one year period.
