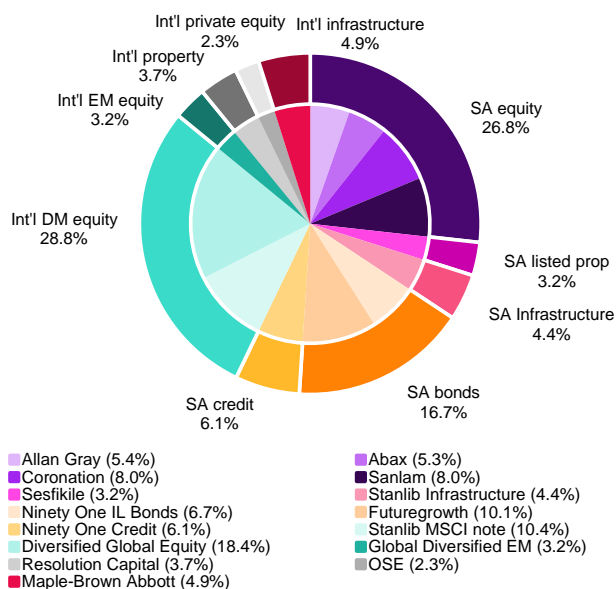

PORTFOLIO DESCRIPTION: The Long Term Portfolio is a market related portfolio that follows a specialist investment approach, diversifying across asset classes and asset managers.

PORTFOLIO OBJECTIVE: The long term portfolio aims to provide a return that exceeds inflation by 5% p.a. net of fees and other costs over measurement periods of at least 8 years.

RISK: The portfolio is intended for members with a long investment horizon. Volatility should be expected over the short term and negative returns may be experienced over a one year period.

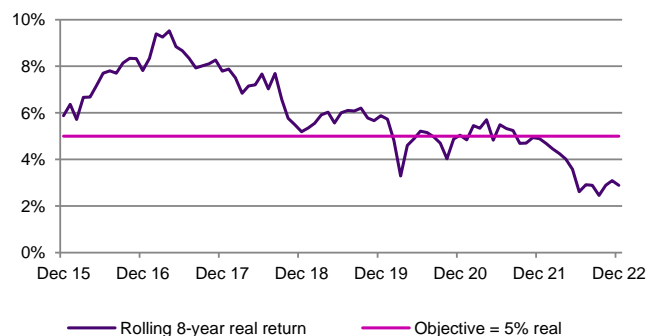
ASSET AND MANAGER ALLOCATION
